



Community Needs Assessment

During the fall of 2022, we conducted a Community Needs Assessment in South Central Wisconsin. The results of this survey provided important information to help us identify areas of future growth in our programs and services while making sure that all current services are aligned with the needs in the community. The resulting growth plan has been informed and guided by the outcome of our assessment process, in addition to validation from numerous secondary data sources. Our roadmap for increasing community impact and doing more GOOD in South Central Wisconsin includes four key components:





RESOURCE SERVICE CENTER

WHY: Accessibility of our programs and services can be enhanced by expanding partnerships with other agencies to provide a holistic approach to helping individuals transition out of poverty with wrap-around services.

WHAT: A Goodwill Opportunity Center will serve as a cohesive, centralized solution to support our current and future program participants with a broad range of community services through partnership with other local agencies.



TRANSITIONAL JOBS

WHY: Foundational job skills are a vital stepping stone to living wage jobs, and transitional job programs address a gap in available training and resources.

WHAT: For community members who have struggled with maintaining employment, a transitional jobs program will help to remove barriers to work while increasing job skills and experience required to maintain gainful employment through coaching, mentoring and training.



EMPLOYMENT

WHY: Goodwill has always believed in the power of work to change lives and build better communities. Living wage employment continues to be a challenge for community members with barriers to work.

WHAT: We look forward to expanding our existing employment programs with an added focus on creating pathways to living wage jobs to support individuals in breaking the cycle of poverty.



AFFORDABLE HOUSING

WHY: Stable, affordable housing is a critical need in our community.

WHAT: We will proactively explore options to expand our residential programs (group homes, subsidized apartments) to address housing instability in our community.

Employment Services

Through our Supported Employment program, adults with disabilities and other barriers to employment build confidence, skills and independence through meaningful jobs in our community, with job coaches providing one-on-one support at no cost to the employer or participant.

By hiring Supported Employment program participants who are assisted by Goodwill staff, employers benefit from reduced turnover and training costs while expanding their workforce with enthusiastic team members. Our long-term relationships and track record of success with Supported Employment job placement at local businesses underscore the many benefits of this program – it's truly a win-win!

Brittany has worked at Edgewood College since 2013. Outgoing, energetic and cheerful, she approaches every day at work with a smile. Her Goodwill Job Coach, Rose, provides the support she needs with her daily tasks. As a dishwasher, Brittany is an important part of the foodservice team and loves the camaraderie with her coworkers.

TERESA



Teresa inspires everyone she meets. Even though she is not able to use her voice to speak, Teresa is able to read stories to children at a local preschool with her Tobii Dynavox and a helping hand from her Job Coach. She also volunteers at the Madison Children's Museum through her weekly program, Tales with Teresa.

Stable Housing

Hundreds of people in our region struggle with homelessness and even more are experiencing housing instability. Our two group homes and 74 subsidized apartment units are a safe place to call home for low-income adults with chronic mental illness, as well as senior citizens.

Group Homes

Adults living with chronic mental illness and other challenges receive 24/7/365 support from our caring staff at our two group homes while learning skills to live independently.

Affordable Subsidized Housing

Low-income adults, retirees and community members with mental illness have a safe place to call home in our eight apartment buildings.

Wesley was the very first tenant in our subsidized apartment complex on Madison's east side. For more than a decade, he has been able to experience stability and connection with his neighbors through affordable housing. He enjoys his life at home and thrives with a sense of community.

JETHRO



Jethro was living in an abandoned vehicle before moving into safe and stable housing at a Goodwill group home. With support from our residential staff, he gained confidence and skills to live independently. Today, Jethro enjoys living at one of our subsidized apartment units - he takes pride in furnishing his home and being a good neighbor.

Volunteer Income Tax Assistance

In partnership with the Wisconsin Department of Revenue and the IRS, our Volunteer Income Tax Assistance (VITA) program provides free income tax preparation for community members with low to moderate income. The VITA program helps many households across our 14-county region every tax season.





JOE BYRNES

In May 2022, Joe Byrnes was honored with the Governer's Service Award as Volunteer of the Year – Southwest Wisconsin. Joe Byrnes serves as the VITA Program Coordinator at Goodwill of South Central Wisconsin. Since he started volunteering with the program in 2018, he has increased volunteer participation and expanded community partnerships, resulting

in a 125% increase in individuals served by the program. Additionally, through his planning and passion, Joe developed a tracking system to allow for ongoing service during the pandemic by quickly pivoting their services to drop-off and virtual tax preparation.



SUE COOK

VITA Volunteer Sue Cook was recognized for her years of service and impactful work with the VITA program. Sue received the Wisconsin Department of Revenue's Outstanding Volunteer of the Year award in 2022. We are deeply appreciative of her dedication to providing excellent service, attention to detail, and unwavering support of the VITA program.

Community Voucher Program

For more than 50 years, Goodwill of South Central Wisconsin has provided support to individuals and families in need through a community voucher program administered by local partner agencies. Hundreds of vouchers are distributed annually to help community members purchase clothing, household goods, furniture and other necessities in our stores through this partnership.

Good for Our Environment

By donating and shopping at our local thrift stores, you are making a sustainable choice – secondhand items are given another chance to be enjoyed while staying out of landfills. Every year, we keep millions of pounds of clothing and household items out of landfills in our 14-county region through responsible recycling and materials management.

Donated Goods Retail

Retail store donations and sales remained strong throughout 2022. Donations increased 16% over prior year, and with a new Attended Donation Center (ADC) opening in Waunakee, we have been


able to provide a convenient location to collect donations in this rapidly growing market.
Retail store revenue increased by 14% over 2021; the revenue that we generate from our 13 area thrift stores stays



right here in South Central Wisconsin and is reinvested directly into our community to fund our housing and employment programs. Thank you, South Central Wisconsin – when you shop and donate at Goodwill, you help fund our GOOD work.

E-commerce

Online sales play an important role in helping us do more GOOD in our local community. Through our three e-commerce platforms, Marketplace, Shopgoodwill and GoodAgain Books, we can generate additional revenue with national reach by listing collectibles, antiques, jewelry, designer clothing and accessories and other one-of-a-kind finds. In 2022, our e-commerce revenue grew 12% over prior year.


